

#### 1.Introduction:-

Natural disasters have been one of the worst enemies of mankind since time immemorial, and various efforts have been made to control, mitigate, or manage them. Though none of these efforts have been fully successful. We have come to realize that natural disasters cannot be controlled, and hence our direction has to be towards managing them to the best of our advantage. One important point to be noted here is that though we cannot control natural disastrous phenomena, we can however, increase their fury with our actions, and this is what we have to avoid as part of our disaster management efforts.

In order to be able achieve all these objectives; the prime need is for collective action of the entire community, and for organizing such a movement. The only river namely 'Dhalai' is flowing towards north direction and her danger level is 67 meters. Every year, it causes flood, which results adverse impacts in the community. Following areas are affected annually:-

(1)Houses and land damage / destroy due to erosion.(2) Household items damage / destroy (3)Loss of lives and injury (4) Livestock / cattle loss /death (5)Water born diseases (6) Transport problems (7) Livelihood problem (8) Crop field damage etc.

As we know, hazard is out of control. But if we increase our capacity, reducing vulnerability, we will be able to avoid disaster. This is why, a well planned Flood Management Plan is required for the Sub Division to reduce vulnerability and risk.

#### 2.Flood in Longtharaivalley Sub Division:

Longtarai Valley Sub-Division is situated in between Longtharai and Sakhan hills under the periphery of , Longthari Valley. Most of the revenue villages of this Sub-Division are situated at the hilly and low-lying areas and the compositions of soil of these areas are gravel mixed with loose sandy and red soil, which makes it prone to land sliding. Most of the villagers live in namely "TONG GHAR" (traditional dwelling house of tribal) build in the hilly areas. As to why a mild storm/cyclone /heavy rain can create loss of a vital part of public property. The Manu river is flowing towards north direction, her semi danger level is 5 (five) meters, danger level 6.5 meters and very danger level is 7.5 meters.

There is a past history of Flood and damage of public properties as well as natural properties caused due to storm occurred in Longtharaivalley Sub-Division.

Each Flood causes 3 (three) types of situation such as-Erosion, Flash Flood and Gradual Flood.

Since no noticeable Flood has happened in the Sub-Division and no warning or forecasting received so far from any corner.



## 23. Search and Rescue & First Aid

Volunteers are given basic practical ideas about the use of country boats and inflatable rubber boats, life jacket, life buoys. At the same time they were trained on First Aid and Rescue operation.

Now these trained staffs, **Fire service** and **Police**, **8**<sup>th</sup> **Battalion TSR**, would be requested to train GP level volunteers on Search and rescue. The BDOs will be suggested to organize the said training programs in GP level as early as possible. The BDOs Manu/CMN will also be requested to conduct GP level Training on First Aid and Rescue operation and keep the contact phone no of the concerned trainee for ready reference and convenience.

In charge of Hospital, Medical Officers would be requested to pre-position sufficient medicines at the vulnerable locations in the Sub Division. Along with life saving medicines, stocking of adequate water purifier and bleaching powder need to be ensured at the sub-division level.


# 24. Rapid Damage Assessment:

#### **Instant Information (of impact) sharing:-**

- (1)Word Member: Families/ community will share the loss; incurred to word member OR Word member would collect information of impact and will immediately share with Pradhan and PRI Secretary
- (2)Pradhan / PRI Secretary: Pradhan / PRI secretary will share the information of the Word Member to the assigned Tahasilder.
- (3) Tahasilder: Just collecting the information, Tahasilder will share the same with SDM, Sector Officer, ADMO (BDO).
- (4)Sector Officer will immediately pass the information to the Sector Assistant(s) for operation
- (5)Sector Assistant(s) will operate along with Volunteers instantly.(Each Sector Assistant will hold the list of GP Volunteers (name, contact no, list of materials available etc in detail)
- (6)In whole process, SDM and ADMO will monitor, coordinate and will extend support for response activities.

#### **Damage Assessment**


The Sub Divisional level Damage Assessment Team will do assessment of damages attaching Tehilder.

Rapid damage assessment would be done just after any Hazard took place within 24hrs with a specified format (Form-A as preliminary report) designed by the Revenue Department (enclosed at Annexure-III). As per the rapid damage assessment, the SDMs and local authorities will extend the interim relief measures to the affected families/ populations. Another damage report in a specified format (Form-B enclosed at Annexure-IV) after initiate the preliminary damage report will be submitted by the DM & Collectors to the Revenue Department for taking up further support to the Districts by placing funds to the District authorities and other government support if required by the District Administrations.
