

MINUTES OF THE MEETING OF DISTRICT PLANNING COMMITTEE, DHALAI DISTRICT FOR IMPLEMENTATION & PREPARATION OF ANNUAL ACTION PLAN FOR 2011-12 UNDER BACKWARD REGION GRAND FUND (BRGF) ON 10-12-2010 AT 11 AM ALONGWITH NABARD (TECHNICAL SUPPORT INSTITUTION) AT THE CIRCUIT HOUSE, AMBASSA.

List of the participants is enclosed at Annexure-A.

1. The Chairman of District Planning Committee (DPC), Dhalai District Sri Gajendra Tripura, E.M. (Agriculture), TTAADC welcomed all the present in the meeting and initiated discussion.

2. The District Magistrate & Collector, Dhalai presented the progress report on the implementation of projects taken up under BRGF (Development Grant) in 2010-11. It is observed that there is maximum allocation given to the power sector but the progress is very slow. The DGM, TSECL, Ambassa/Manu/Kamalpur have raised the issue of shortage of PCC poles & other electric materials. All the works should be completed positively by 31-01-2011 so that the balance allocation of BRGF of 2010-11 can be claimed by the Dhalai District.

3. It is noted that the project at Sr. No.26 as approved by HPC for 2010-11 i.e. "Construction of road from AA Road to Shikaribari Tower" with estimated cost of Rs.232.50 lakhs under BRGF 2010-11 is being implemented by PWD (R & B) from their own source of fund. Therefore, it is decided that the following projects may be taken up as alternative in 2010-11.

4. The NABARD has been entrusted with the preparation of Draft Annual Action Plan for the year 2011-12 and are working on this issue since September 2010. They have conducted meetings at the block level & Nagar Panchayet Level & the report is enclosed in **Annexure-'B'**

5. As per the Annual Action Plan submitted by the NABARD, it has been decided that the small projects should be taken up under existing CSS/State Govt. Schemes & only the large projects (above Rs.10 lakhs) should be taken up under the special programs like BRGF, BADP,NLCPR & ACA/SPA.
6. As per the above suggestions and the inputs by the various Line Department Officials, BDOs as well as members of District Planning Committee and based on cost benefit analysis of the proposed projects, few selected projects have been considered for inclusion in BRGF (Development Grant) 2011-12.
7. The District Planning Committee, Dhalai District, therefore, hereby approves the list of projects mentioned **Annexure-'C'** for inclusion under the BRGF (Development Grant) for 2011-12. Accordingly, this list may be forwarded to the HPC under the Chairmanship of the Chief Secretary, Tripura for final approval.
8. The District Planning Committee, Dhalai District has considered that other important projects as mentioned in **Annexure-'D'** for funding under ACA/SPA 2011-12.
9. The District Planning Committee, Dhalai District also resolves that the remaining shelf of projects mentioned in the draft annual action plan submitted by NABARD for inclusion under the various other schemes like MGNREGA, NRHM, National Horticulture Technology Mission, RDVY, SSA, PMGSY, TGGVY, PDF, TFC & various related scheme as per the guidelines mentioned therein.
10. The next meeting of the District Planning Committee shall be in March 2011 tentatively.
