MINUTES OF THE DEVELOPMENT MEETING HELD ON 13-01-2010 AT CHAWMANU HAC HALL AT CHAWMANU RD BLOCK

The special BAC meeting was held under the chairmanship of Chairman, Block Advisory Committee. The list of the participants is given in the annexure. The main points of discussion and decisions taken are as follows.

NREGA:-

- 1. Total 53 mandays per family have been provided during 2009-10 which includes 14 mandays provided from spillover fund and 38 mandays from the current year fund.
- 2. The average mandays generated in West Chawmanu & Rajdhar V/C was below 30. The Chairpersons & BDO, Chawmanu have been requested to put efforts for providing more mandays to these areas specifically in Rajdhar V/C.
- 3. All the members of BAC and Chairpersons of Village Councils were requested to prepare a list of works worth 30 to 40 lakhs in each village which can be taken up from January to March,2010. The technical estimate will be prepared in advance for these works.
- 4. Some members raised the issue of delay in preparation of estimates. The BDO,CMN & EE,RD were requested to ensure that whole process of preparing technical estimate and giving sanction should be completed within 10 days from the date of receipt of a resolution from Panchayet. Any delay will be viewed seriously against the Technical Assistants.
- 5. Some members raised issue of delay in NREGA wages payment through bank account. The BDO,CMN to take up the matter with the bank officials to ensure timely payment of NREGA wages.

Agriculture:-

- 6. According to Superintendent of Agriculture, Manu, total cultivable land is 925 Ha. An ambitious target of 610 Ha during 2010-11 have been fixed for developing additional cultivable land in the Block. SA has been requested to work out the target afresh for 2010-11 and 2011-12 panchayet wise. The target should be reasonable which can be achieved.
- 7. The target for bringing more area under cultivation should be discussed in BAC meeting and fund may be sought under NREGA. The SA to submit the action plan within **25**th **January** to the BDO,CMN.
- 8. Target for SRI during 2010-2011 should be made to 50 Ha instead of just 5 hectors.

Horticulture:-

9. The Principal Officer, Agriculture(TTAADC) and Superintendent of Horticulture were requested to start work on rejuvenation of Durgacherra Horti Orchard. BDO,CMN will provide fund from NREGA as per demand of Superintendent of Horticulture.

- 10. The Superintendent of Horticulture will target @20 Forest Right beneficiaries per village for horti plantation under NREGA. Two nurseries will be set up by Superintendent of Horticulture under NREGA for taking up Mango, Coconut, Aracanat & Jack Fruit plantations.
- 11. There is a good amount of fund lying unspent under RKVY and Technology Mission schemes with Dy. Director, Horticulture, Ambassa. The Principal Officer, ADC may seek this fund for development of Horticulture activities in ADC areas.

Irrigation:-

- 12. The progress on extending irrigation facilities in Chawmnau RD Block was found to be unsatisfactory. The figures of area brought under irrigation received from Water Resource Department and Agri Department did not match. It was decided that the Water Resource officials and Agri Department officials will have a joint survey to find out actual area under irrigation.
- 13. The EE, Water Resource, Kamalpur was requested to chalk out a plan for bringing new areas of Chawmanu RD Block under irrigation in consultation with the Asstt, Engineer, Water Resource (ADC), BDO, Chawmanu and BAC members.
- 14. The Asstt. Engineer, Water Resource, TTAADC was requested to immediately prepare estimates for repairing of non-functional Irrigation schemes in Chawmanu RD Block. Estimates to be submitted to the BDO, Chawmanu for further action.
- 15. As per the suggestion of the Chairperson V/C, one big irrigation scheme at North Longtharai Village will be taken up under NREGA. The EE, RD & AE, WR, TTAADC will jointly prepare the technical details and financial estimates of the work within **15-days**.

Road Connectivity:-

- 16. The progress of work done by HSCL was found to be unsatisfactory. The EE,PWD(R&B), Manu has been requested to take up the matter with state headquarter for improving road connectivity work under PMGSY.
- 17. The EE,PWD(R&B), Manu to immediately start the work of formation of road from Thalcherra to Hariamunipara. The fund of Rs.30 lakhs under BADP available for one Bailey bridge at Hariamunipara may be used for this purpose.
- 18. The EE, PWD,Manu has also been requested to conduct survey and prepare an estimate for taking up road formation work from Thuichandrapara to Hardayalpara under Rajdhar V/C.
- 19. SDM,LTV will convene a meeting with PWD, Health, Forest & Police officials for preparing documents related to diversion of forest land for construction of PHC, Health Sub-Centre and TSR camps.

Handloom, Handicrafts & Sericulture:-

- 20. The Dy. Director, Handloom, Handicraft & Sericulture requested for allotment of land near the office of BDO,CMN for departmental office. SDM to look into the request.
- 21. The Dy. Director, Handloom, Handicraft & Sericulture will develop one cluster of Forest Rights beneficiaries for taking up sericulture activities in Chawmanu RD Block. The fund can be provided under NREGA.

Forest Rights:-

22. The SDM,LTV informed that all the Forest Rights have been approved and distributed to Panchayets. The Village Council members were requested to ensure that distribution of some left over pattas to the actual beneficiaries will be completed within 15th January,2010.

Fisheries:-

- 23. The Superintendent of Fisheries informed that only 5 Ha of water bodies created during 2008-09 has been provided with fish inputs. The Superintendent of Fisheries was requested for targeting 88 Ha water bodies created during 2008-09 & 2009-10 under NREGA for providing fish inputs in 2010-11.
- 24. The Superintendent of Fisheries requested for providing suitable land for establishing one soil & water testing laboratory at Chawmanu. The SDM,LTV to look into the matter.

Health:-

- 25. The CMO,Dhalai briefed the participants about the present health scenario of Chawmanu RD Block. He informed that sporadic cases of meningococcal, malaria and diarrhoea are being reported. However, health camps in a planned manner are being conducted regularly.
- 26. The Chairperson, V/C, Manikpur informed that the appointed Doctor, at Manipur PHC remains absent. The same was also corroborated by other Chairpersons and BDO, Chawmanu. The CMO,Dli was requested to ensure that the Doctor regularly attends Manikpur PHC as this is the nearest hospital for 4 remote villages.
- 27. The BDO, CMN reported that the vaccination, de-worming and pulse polio campaign has not been done at Ganarampara and Gangajoypara of West Malidhar V/C. The BDO,CMN will submit list of such other paras to the MOIC,CMN PHC so that a special drive is taken for vaccination & de-worming in these paras by the CMO,Dhalai.
- 28. The CMO, Dli was requested for providing vaccination against meningitis to the left over persons in **Chawmanu RD Block**.

Drinking Water:-

29. A comprehensive **special action plan** for tackling coming up dry spell has been prepared and is being implemented.

- 30. Every village have been provided <u>@Rs.2</u>.00 lakhs for minor repairings and construction of kaccha wells wherever required.
- 31. It was disappointingly noticed that despite repeated promises, the Drinking Water Department has not been able to make Manikpur DTW functional. The EE,DWS informed that due to delay in finalization of tender, the work could not be taken up. The EE,DWS was requested to take up the matter with HQ so that work is completed by **March,2010.**
- 32. The BDO,CMN reported that awareness generation programme against water borne diseases by teams of experts from Health, Social Welfare & ICAT Department has already started. He was requested to intensify such awareness generation activities in remote areas.
- 33. The SDO (DWS), Chowmanu to shift his office from Manu to Chowmanu within **20-01-2010.**

ARDD:-

- 34. Principal Officer, ARDD(ADC) briefed on the progress of ARDD activities in Chowmanu RD Block. The efforts to be made to spend BRGF fund immediately.
- 35. The veterinary sub-centre sanctioned under BADP will be constructed at Manikpur.
- 36. Principal Officer, ARDD to prepare **special action plan** for ARDD activities covering 100 to 150 SHGs who are beneficiaries of Forest Rights Act. The Action plan to be submitted village-wise with SHG details to BDO,CMN within **15**th **Feb 2010**.

Power:-

- 37. The progress of laying down power lines was slow in Chawmanu RD Block. The DGM, TSECL has been requested to complete the power line work up-to Thalcherra and Gobindabari within March 15, 2010.
- 38. The DGM, TSECL to submit estimates for projects proposed under BADP during 2009-10 & 2010-11. Additional proposal for covering Manikpur to Thuichandrapara under Rojdhar V/C to be submitted to DM office immediately.

Education:-

39. The I/S informed that 14 SB Schools in Chowmanu RD Block are being run by proxy teachers and 10 are not functioning at all. The DEO, Dhalai to take action against the erring teachers.

Social Welfare:-

- 40. Some Chairpersons complained about delay in payment of pension under NOAP scheme. The DISE was requested to look into the matter.
- It was also complained that during transfer of NOAP scheme from BDO to CDPO, pension for certain period has not been received. DISE may look into the matter & take corrective measures.
- 42. It was decided that Dy. Director, ARDD/Horti/Fisheries will regularly monitor the work of respective Superintendents/Assistant Directors posted under ADC in the District. The Principal Officer, TTAADC also promised that these officials of ADC area will regularly send progress reports of different schemes to the Dy. Director for monitoring. Action will be taken against the concerned officials who will not adhere to the advice of Dy. Directors.
