

**Minutes of the meeting of DZSS held at 11.30 a.m.
on 20th March, 2010 in the conference hall of Zilla Parishad, Ambassa**

The list of dignitaries and other guests, attending the meeting of ZSS is given in **ANNEXURE-I**.

2. At the outset the Chairman ZSS Dhalai after welcoming the participants of the meeting explained the reasons for calling such meeting. He then requested the ADM & Collector Dhalai to explain the components of two programmes of **SALP & Saakshar Bharat Mission - 2012**. The ADM & Collector discussed in detail the different aspects including objectives of the two programmes. While Saakshar Bharat Mission is yet to gain momentum, the Special Adult Literacy Programme would have to be restarted and made functional so as to achieve 100% literacy in Dhalai district.

3. Thereafter Block Coordinators of all Blocks reported on the number of illiterates, number of literacy centres made functional, no. of VTs engaged etc, which is reflected in **ANNEXURE-II**.

4. The D.M. & Collector, Dhalai requested for gearing up the activities of literacy programme and conduct resurvey in the interior villages of Chawmanu- and other places to include any leftout illiterates.

5. Smt. Pranati Das, Sabhadhipati, Zilla Parisad, Dhalai; Shri Prasanta Debbarma, MLA; Chairpersons of Panchayet Samitis/BAC of Salema, Chawmanu, Chairman and Ambassa Nagar Panchayet; Chairman of BSS, Salema; SDM, Ambassa/ Kamalpur also took part in the discussion and gave suggestions.

6. The following decisions were taken unanimously in the meeting:

(i) Although most of the literacy centers are expected to be reopened by 20th March, yet the rest of the centers shall have to be made functional by **30th March, 2010**. (Action: BDO).

(ii) Block wise Special meeting shall be convened inviting concerned Pradhan/Upa Pradhan; Chairman/Vice-chairman of GPs/VCs, local officials of Education Department/SW & SE department and other line departments to sensitize and draw up action in each Block of the district. The VTs/ Preraks/Literacy workers may also be invited.

The BDOs shall prepare a detail report identifying the gaps and finalizing the steps to be taken to bridge the same in the Block level meeting.

(iii) A separate meeting in each Block shall be organized with voluntary organizations/NGOs/Youth & Women organization/local teachers/in-service or retired employees of different departments inviting them individually. (Action: **By BDOs by 10th April, 2010**).

(iv) Similar meetings shall be organized in Kamalpur and Ambassa Nagar Panchayats inviting the Chairpersons of Nagar Panchayat/members and others concerned. (Action: **by EO by 1st week of April, 2010**).

(v) CDPOs and Supervisors of SW & SE Department are requested to actively involve in the SALP. It was again reiterated that their performance on Adult literacy front will be recorded in their ACRs. Services of the AWW shall also be ensured for the literacy centers. (Action: **By DISE**)

(vi) For IEC activities, ICAT department is preparing Publicity material to be placed at Block/Sub-Divisional Hqrs. The Dy. Director, ICAT, Dhalai to ensure that the work is completed in time. (Action: **By Dy. Director, ICAT, Dhalai**).

(vii) It was reported that some of the areas, particularly wards of GPs/Nagar Panchayats, have become 100% literate. It has been decided that such areas will be declared as 100% literate in the following manner-

- a) By a resolution to be adopted in a Ward Sabha and GP/Village Sabha;
- b) By a resolution to be adopted by the Panchayat Samity/BAC/Nagar Panchayat after the literacy center wise evaluation is completed for all learners through the process of ward/GP/Village Sabhas;
- c) The concerned BDO will have to certify in respect of his/her jurisdiction to this effect;
- d) Based on the certificate of the BDOs and EOs, the ZSS will review and pass a resolution on the status of the Adult Literacy Programme for the entire district.

(viii) GP/VC level meeting shall have to be organized just after the Block level meeting to ensure the regular functioning of the literacy centres. (Action: BDOs/ Block Coordinator).

(ix) The BDOs to conduct resurvey of difficult areas such as Rajdhar, East Malidhar, West Malidhar, Chalitacherra and Natin Manu reporting less illiterates by 5th April, 2010. (Action: **By BDO, Chawmanu**)

(x) Resurvey work in other places, if required, shall be completed by 5th April 2010 and list of illiterates along with a CD copy should also be forwarded to ZSS office by **8th April, 2010 without fail.** (Action: **By BDOs**).

(xi) The monitoring committee at Gram Panchayet/Village committee level shall monitor the programme on a regular basis to present dropouts. (Action: **By BDOs/Block Coordinator**)

(xii) All BSS shall be responsible for submitting monthly progress report (centre wise), signed by the BDO, to ZSS office for release of centre contingency. (Action: **By BDO/Block Coordinator**).

(xiii) All SDMs/BDOs/DCMs/Officers of line departments were requested to visit the literacy centres so as to monitor properly and submit report to the ZSS.

(xiv) All BSS will organize meetings with identified illiterates in particular pockets like tea garden areas and invite experts from line departments for talks on different schemes for bringing awareness among illiterates. District level official may also participate in such meeting. (Action: By BDOs/ Block Coordinators).

(xv) All the BDOs will send report on the minutes of the meeting by 5th April, 2010.
