1. E.M.D. shall be refunded to unsuccessful tenderers after final selection of successful tenderer.
2. The Office of the DM & Collector, Dhalai District intends to purchase 1No. of 2 Ton Split Air Conditioner with stabilizer for installation at DeGS Room.
3. The Specification of the Air Conditions is as follows:-

4. The farm should submit GST Clearance certificate from the competent authority along with the tender paper.
5. Each Tenderer is required to deposit an earnest money (EMD) of Rs.5,000/- (Rupees five thousand only) in form of a Bank Draft should, drawn from a nationalized bank, drawn in favour of "DM & Collector, Dhalai District".
6. The earnest money for unsuccessful farms shall be returned on the finalization of the tender without any interest.
7. The price and conditions of the offer should be valid for at least a period of six months from the date of tender opening.
8. Value of each item with total and grand total of whole tender should be written clearly. Corrections or overwritten amounting to unreadable may disqualify the tender. Clerical and arithmetical mistakes may result in rejection of the tender.
9. The tender shall make his own arrangements for supply and installation of materials at the purchaser's site.
10. The site address will be furnished to the vender along with the work order.
11. All the equipments supplied are subject to satisfactory operation for a period of 3 years from the date of commissioning. The vendor will provide onsite comprehensive warranty for 3 years excluding printer head which shall be for one year. The vendor will have to rectify any defects during the warranty free of cost within 72 hours of the receipt of complaint.
12. The prices quoted should be firm and inclusive of all duties like sales tax, entry tax, excise and any other taxes.
13. Payment will be making after supply and proper installation of the Air Condition.
14. The successful bidder should deliver all the goods in good condition within 15 days of issue of the purchase order.
