

## **Tour Note**

On 18-07-2009 I started from Ambassa alongwith Vidhya Bhusan, IAS, Probationer at 8:30 am for Manu to visit Dhumacherra area. First I had a discussion with BDO,MNU & SDM, Longtharai Valley at Dak Bunglow, Manu. The main points of the visit are as follows :-

1. I visited the present location of Dhumacherra PHC. The land leveling had been completed and foundation work had just started. This location is around 4-10 kms. away from main villages namely Longtharai RF, South Dhumacherra, Battala, Demcherra, West Machli and North Dhumacherra for which it is being constructed.

2. The house of one Smt. Usha Rani Tripura is located over the present location and requires immediate shifting. She had requested for allotment of some khas land and to provide one IAY house. The SDM,Longtharai Valley has been instructed to allot 5 ganda of land in a nearby khas land plot. One IAY house will be provided from this end.

3. The local people and some leaders reported that the present location is very close to existing Manu PHC. Therefore, Dhumacherra PHC should be constructed at the tri-junction of "Kartik Debbarma" Para, which is very close to these 6-villages.

4. I alongwith SDM, LTV; BDO,Manu & the locals visited Kartik Debbarma Para where one SPO camp is also located. There is sufficient khas land and some PF land available over which construction of PHC can take place. SDM,LTV; BDO,MNU and the local leaders suggested that this is the best location of this PHC, as it is very close to 6(six) villages. It was decided that the PWD will be requested to change location of the PHC and construct it at "Kartik Debbarma Para".

**(Action by EE,PWD,MNU)**

5. I visited Jatindra Reang Para where because of non-availability of sufficient khas land, the construction of PMGSY road has been stopped. I had a discussion with Sri Nirajoy Tripura, headman of the village who promised to give much needed jote land provided some ponds are constructed by the Govt. as an alternate means of income generation. His request could be accommodated under NREGA scheme. If the jote land is made available by the villagers free of cost, then the construction of another 3-4 kms. of road will help connecting around 100-200 families of upper longtharai village. This road will also help in easy movement of people and security personnel. BDO,MNU to hold a meeting and decide on the matter.

**(Action by SDM,GNC/EE,PWD/BDO,MNU)**

6. One TSR camp is located in Jatindra para JB School building and therefore, the School is being presently run from the residence of Sri Sumanjoy Tripura, the headman. They requested for construction of one School building for its smooth running. The Dy. Director, Education, Dhalai to provide fund (around Rs.2-3 lakhs) from SSA during 2009 so that the School can be constructed.

**(Action by Dy. DIR,EDU,DLI)**

8. On return, I visited Dhumacherra Growth Centre. Except motor stand, all other components like community hall, sports gallery, market shed etc. have been completed. After completion of motor stand, the Growth Centre will be ready for inauguration latest by 1<sup>st</sup> week of October, 2009.

**(Action by EE,RD-D/BDO,MNU)**

9. I had a discussion with BDO,MNU and took stock of election preparedness in Manu Block and finally return back to Ambassa by 2:00 pm and then attended office work.
