

## Tour Note

On 21-06-2009 (Sunday), I started for Ambassa & Kmalpur Sub-Division at 8:30 am and returned back by 5:00 pm. During the visit, I was accompanied by the Dy. Director, PGP, Ambassa and his Programme Officer.

### Ambassa Sub-Division :-

i. Inspected six no. of dam constructed by PGP Department under NREGA in Jeolcherra ADC Village. Around 90 regrouped families are getting benefits from these check dams. Dy. Director, PGP has been requested to prepare an action plan for taking up long term plantation of Horticultural trees in this area under NREGA during the current financial year.

### Reang basti under Kamalpur Sub-Division:-

i. First visited Reang basti BSF BOP. The Officer-in-Charge requested for providing 3(three) solar lights for BOP. The fund could be provided from SRE.  
**(Action by O/C, JDL)**

ii. We visited Saniya Reang Para. We had interacted with Village Committee Member and around 10-15 local people. On inspection of some of the job cards, it was found that sufficient person days of work was provided during 2008-09 under NREGA. However, hardly any work could be provided since April, during current financial year.

iii. On detailed discussion with local people, it was decided that Dy. Director, PGP will prepare **an action plan** for overall development of this village which will interalia include construction of Community Hall providing drinking water, AWC etc. **(Action by Dy. Dir, PGP)**

iv. Dy. Director, PGP will organize one general awareness camp in the village for the benefit of 131 Reang families. The camp will aim at generating awareness about Govt. Schemes, maintenance of cleanliness & hygiene and importance of education.  
**(Action by Dy. Dir, PGP)**

v. We met with one teacher namely Sri Kharendra Reang posted at Saniya Reang Para SB School. Total other 3(three) teachers namely Sri Amar Singh, CT; Sri Amar Debbarma, CT and Sri Punahari Reang, School-in-Charge are only posted.

vi. Local people requested for construction of one kitchen shed and providing some furniture to the class rooms. They also reported that Sri Amar Sinha and Sri Amar Debbarma visit the School hardly 2-3 days in a week because of which the students are suffering a lot.

**(Action by Dy. Dir, Education)**

vii. On scrutiny of attendance register for teachers, it was seen that Sri Amar Singh, CT and Sri Amar Debbarma, CT were found to be absent on 15-06-2009 and 17-06-2009 without any application and prior permission. This was noted by the SDM, Kamalpur during

his inspection but no action has been taken till date. **The Inspector of Schools, Kamalpur** should take action against the teachers. Sri Purnendu Reang had placed a leave application w.e.f. 20-06-2009 to 27-06-2009 addressed to the Inspector of School, Kamalpur. As this application has not been sent to Inspector of Schools, it is clear that he wanted to keep application in the School as alibi for his absence and later on destroy it. Inspector of School should regularly visit the School and take action against **Sri Purnendu Reang.**

**(Action by IS, KMP)**

viii. The Co. Commander of Reangbasti & Sanjoy BOP informed that they had placed a requisition with AGM, TSECL for extending electricity to their BOPs. However, AGM(E) could not extended the electricity for shortage of poles. DGM,TSECL,KMP to look into the matter and take action accordingly. **(Action by DGM,TSECL,KMP)**
