

Tour Note

On 10-02-2009 I started from Ambassa at 8:00 am for Gandacherra Sub-Division and reached by 9:30 am. I returned back to Ambassa on 11-02-2009 by 2:30 pm and then attend office work. During my stay, I had a meeting with the SDM, Gandacherra and officers of all departments including BDO, Dumburnagar. I also inspected some of the ongoing construction works. The main points of the visit follow :-

1. At Boalkhali ADC village, an advance of Rs.5,47,135/- was drawn by the Panchayet Secretary with cash in hand. Out of this money Rs.4,46,982/- was meant for bricks. The Panchayet Secretary reported that he was paying expenditure for material components through cash. The BDO, DBN to ensure that all such practices are stopped henceforth. All the payment except for wages and petty expenses payment should be made only through A/C payee cheques. The instruction should be passed to all the GP's and other implementing officers.

2. The muster rolls for the works which have already been completed should be properly filed up and duly signed by all the concerned officials and the same should also be sent to the DM Office for up-loading.

(Action by BDO,ABS/CMN/DBN/MNU/SLM)

3. The present IAY house estimate should be modified with a provision for one mtr. height of brick wall over the ground, Sanitation part of the IAY construction will be met from the TSC fund.

4. On 10-02-2009 at 6:00 pm, a lengthy discussion was held with the officials of all departments. They gave an idea of various activities taken up in Gandacherra Sub-Division. The minutes of the meeting to be issued by SDM, Gandacherra.

5. Dr. Billwa of ARDD Department stated that the medicine for treatment of animal is not available in the stock. I suggested in case of urgency, some medicine may be purchased from CRF also.

6. Next day on 11-02-2009, I visited Hatimata Tilla under Dalpati ADC Village. Here, I saw proposed site for establishing one regrouping village by bringing scattered Jhumia

families from Dalapati/Kallyan sing ADC villages. BDO, Dumburnagar will prepare project proposal in consultation with other line departments.

7. I inspected one bridge construction over Mallyansing cherra at Hatimata with an estimated cost of Rs.31 lakhs. The dimension of the bridge was 6.00 x 21.10 mtrs. Some modification of the design was done by increasing 0.5mtr. Additional cost will be met from NREGA.

8. Another bridge was being constructed over Mallyansing Cherra near Panchayet Office. It was found that the construction was not as per the technical estimate. The Junior Engineer has been asked to compare the actual construction physically with the technical estimate and then report on the difference. The physical estimate for construction of retaining wall was not done properly.

9. The BDO, DBN reported that the rubber plantation at Taraban colony for 93 families was to be done at the cost of Rs.26,25,000/-. The expenditure for an amount of Rs.19,33,650/- has already made but till date not a single plant has been planted. The BDO, DBN has been asked to look into the matter and send an enquiry report immediately.

10. BDO, DBN to prepare plan for establishing one mother plant nursery on rubber under NREGA during 2009-10. He will also look into the possibility for setting up Horti nurseries on coconut, pineapple etc.

11. BDO requested for placement an amount of Rs.40,000/- for maintenance of BDO office. Development Section will release fund.

(Action by BDO,DBN)

12. SDM, GNC & BDO, DBN reported that the bank interest has not been credited in the Savings Bank Accounts for all the developmental schemes by the Tripura Gramin Bank, Gandacherra. The BDO, DBN and SDM, GNC to take up the matter with Tripura Gramin Bank in writing and in case, interest is not credited timely penal action will be initiated.
