

**TOUR NOTE OF SRI VIKAS SINGH, IAS, DISTRICT MAGISTRATE & COLLECTOR, DHALAI
TRIPURA TO KAUBAHA VILLAGE ORGANIZATION (VO) IN KATHALBARI VC IN AMBASSA R.D.
BLOCK UNDER TRLM PROJECT ON 26/08/2016.**

The undersigned visited Kaubaha V.O in Kathalbari VC under Ambassa R.D. Block at 4.00pm accompanied with Block Mission Coordinator, TRLM Ambassa. After arriving there a short discussion was held with the members of 2 (Two) Nos. of the SHG of the said V.O.

1) **TUISANAI MUTOH SHG:** The SHG consisted of 8 (Eight) nos. women members. The bank account of the SHG has already been opened. The SHG has been rated as 'A' grading. The SHG has been provided Revolving Fund (RF) @ Rs. 10,000/- only & Community Investment Fund amount @ Rs. 60,000/-only. The SHG is involved in livelihood activity such as Piggery, Goatery, Duckery, Cow rearing etc. The monthly income of the SHG was found to be around Rs. 12,000/-only per month. The SHG members are also making the repayment back to the VO since last month.

2) **Pine SHG :** The newly formed SHG has been rated as 'B' grading and the SHG account has already been opened. The SHG has been provided Revolving Fund @ Rs. 10,000/- only and the Community Investment Fund (CIF) amount @ Rs. 60,000/-only. The SHG is engaged in livelihood activities like piggery, cow rearing & tea stall etc. However, the monthly income is found to be nil. In this regard, the Block Mission Coordinator has been directed to ensure sustained monthly income for the SHG.

During further interaction with all members of the SHG, it was found that the members are interested in skill development training in tailoring, candle making & handloom etc. The Block Mission Coordinator & PD, DRDA, Dhalai has been requested to prepare proposal for imparting training to the eligible SHG members under LIFE MGNREGA project to be implemented by the UBI-RSETI, Ambassa Dhalai by 31-08-2016.
